#### RENEWAL DETERMINATION

Determination: [2005] IASC 122 Renewal of: [2001] IASC 106

The Route: Indonesia

# 1 The application for renewal

- 1.1 On 21 May 2001 the Commission issued Determination [2001] IASC 106 (the Determination) allocating 780 seats of capacity per week to Qantas on the Indonesia route.
- 1.2 Under the *International Air Services Commission Act 1992* (the Act) the Commission must start its consideration of the renewal of a determination at least 12 months before the expiry of the Determination. The Determination expires on 29 July 2006.
- 1.3 Qantas applied to the Commission on 30 August 2005 for a renewal of the Determination. The Commission published a notice on 6 September 2005 inviting submissions or other applications for an allocation of the capacity subject to renewal. No submissions or other applications were received.
- 1.4 All material supplied by the applicant is filed on the Register of Public Documents.

### 2 Commission's consideration

- 2.1 Under the Minister's Policy Statement (No. 5) of 19 May 2004, there is a rebuttable presumption in favour of the carrier seeking the renewal. The Commission notes that:
  - Qantas has been fully utilising the relevant capacity;
  - according to the Register of Available Capacity there are 6,390 seats per week remaining available for allocation to Australian carriers for passenger services between Sydney, Melbourne, Perth and Brisbane and

- authorised points in Indonesia; and unrestricted capacity between other Australian points and authorised points in Indonesia;
- there are no other applicants seeking capacity on the route; and
- there is no evidence that Qantas has failed to service the route effectively.
- 2.2 In these circumstances, the Commission concludes that the renewal of Determination [2001] IASC 106 would be of benefit to the public.
- 2.3 The wording of the fresh determination below reflects the view of the Commission that determinations which renew original determinations should contain updated terms and conditions consistent with the Commission's current practice and current air services arrangements. Under the Act, the Commission may make changes to the terms and conditions included in the original determination where warranted by changes in circumstances since the original determination was made.
- Determination for renewal of Determination [2001] IASC 106 allocating capacity on the Indonesia route to Qantas ([2005] IASC 122)
- 3.1 The Commission makes a determination in favour of Qantas, allocating 780 seats weekly between any points in Australia and authorised points in Indonesia under the Australia Indonesia air services arrangements.
- 3.2 The determination is for five years from 30 July 2006.
- 3.3 The determination is subject to the following conditions:
  - Qantas is required to fully utilise the capacity;
  - only Qantas is permitted to utilise the capacity;
  - Qantas is not permitted to utilise the capacity to provide services jointly with another Australian carrier or any other person without the prior approval of the Commission;
  - changes in relation to the ownership and control of Qantas are permitted except to the extent that any change:
    - results in the designation of the airline as an Australian carrier under the Australia – Indonesia air services arrangements being withdrawn; or
    - has the effect that another Australian carrier, or a person (or group of persons) having substantial ownership or effective control of another Australian carrier, would take substantial ownership of Qantas or be in

a position to exercise effective control of Qantas, without the prior consent of the Commission; and

• changes in relation to the management, status or location of operations and Head Office of Qantas are permitted except to the extent that any change would result in the airline ceasing to be an airline designated by the Australian Government for the purposes of the Australia – Indonesia air services arrangements.
