## APPLICATION BY QANTAS FOR ALLOCATION OF AIR RIGHTS ON THE UAE ROUTE -VICTORIAN GOVERNMENT RESPONSE

I am writing to provide the Victorian Government's position on the recent application by Qantas Airways (Qantas) for an allocation of fourteen frequencies per week on the United Arab Emirates (UAE) route, in order to operate daily services to London, via Dubai, from Melbourne and Sydney.

Victoria and Australia's competitive position as a global tourism destination is reliant upon its air traffic capabilities. Direct air services between Victoria and key markets are critical to growing Victoria's other export sectors, particularly investment, trade and international education.

Victoria has an important and long standing economic relationship with the UAE and established a Victorian Government Business Office in Dubai in 1997. The UAE is an important growth market for airline services, both in developing direct links to the UAE and in accessing links to markets in the UK and Europe.

According to Australian Passenger Card Data, in the year ending June 2012 there were more than 52,493 passenger movements between Melbourne and the UAE, a 4.2% increase in passengers from the previous year. During this same time period, there were more than 500,000 passenger movements between Melbourne and the UK, with the UK set to remain one of Victoria's core visitor markets out to 2020.

Qantas is a key carrier for Victoria for flights to the UK and Europe and we expect this trend to continue with the airline's proposal to transfer the majority of its connecting Melbourne-London passenger traffic over Dubai, rather than Singapore. Dubai, through Victoria's current triple daily Emirates' flights, is already positioned as a primary connecting hub for passenger traffic travelling to and from Victoria to the UK and Europe.



In line with our support for the proposed alliance between Emirates and Qantas we are supportive of this application by Qantas for the allocation of fourteen frequencies per week on the UAE route for the operation of services to London, via Dubai, including daily services from Melbourne.
